DAY 1 THURSDAY, OCTOBER 19

We will fly from Minneapolis to San Francisco, City by the Bay! Upon arrival, we will transfer to our hotel which is located in the heart of the Fisherman's Wharf District. *Holiday Inn Express & Suites San Francisco Fisherman's Wharf (5 nights)*

DAY 2 FRIDAY, OCTOBER 20 (B)

This morning after breakfast, we will travel across the Golden Gate Bridge and through the rugged coastal mountains of Marin County. Our first stop is Muir Woods National Monument where ancient groves of Giant Redwoods tower over Redwood Creek. Next we visit the beautiful coastal town of Sausalito, a gorgeous Mediterranean-style village with quaint shops, art galleries and waterfront restaurants. We will continue with our tour of San Francisco like you've never seen it before! Tour the city from the Bay to the Ocean, with photo stops at key locations. Enjoy great views and visit famous attractions, including the Golden Gate Bridge and Park.

DAY 3 SATURDAY, OCTOBER 21 (B)

Today is free to enjoy the sights of San Francisco and Fisherman's Wharf. If you chose, you can walk to Boudin San Francisco Sourdough and enjoy a self-guided tour of the Bakery Museum. You have a meal voucher to use when you chose at the Baker's Hall Café. Fisherman's Wharf and all of its attractions and shops is all within walking distance of the Holiday Inn Express & Suites.

DAY 4 SUNDAY, OCTOBER 22 (B)

This morning, we will use San Francisco's public transportation for a short ride to The Embarcadero & Bay Street to ride Alcatraz Cruises to visit Alcatraz Island, the legendary island that has been a civil war fort, a military prison and one of the most notorious federal penitentiaries in US history. We will each have a 45-minute Cellhouse Audio Tour, featuring actual correctional officers and prisoners who lived and worked on the Island. Everyone can return on the ferry at their own time and return to the hotel with time in Fisherman's Wharf.

DAY 5 MONDAY, OCTOBER 23 (B)

We will head out of San Francisco today and visit the renowned Napa Valley and Sonoma Wineries for tasting, learn about winemaking techniques, and shop for wines and souvenirs in local shops. We will taste the finest wines of Napa Valley and have free time for lunch and shopping in Yountville.

DAY 6 TUESDAY, OCTOBER 24 (B)

It's time to return to Minneapolis. We will transfer to the San Francisco International Airport for our flight to Minneapolis-St. Paul International Airport.
