### **Day 1 Wednesday, September 5 (L) K Bar S Lodge, Keystone, SD (1 night)**

Today we begin our journey to the northern National parks of the great Rocky Mountains. This evening you will have time to shop and dine in the beautiful little town of Keystone, SD before settling into our mountain lodge for the evening.

### **Day 2 Thursday, September 6 (B) Best Western Plus, Billings, MT (1 night)**

As we venture out today we will visit the Mount Rushmore National Memorial before making our way to Billings, MT for the evening.

### **Day 4 Saturday, September 8 (B,L) Pine Lodge, Whitefish, MT (2 nights)**

We will arrive in Glacier National Park and will make our first stop at Lake McDonald where we will enjoy lunch and a 1 hour scenic cruise. Experience the majesty of the Continental Divide and the tranquility of the emerald-hued lake as we cruise along Lake McDonald, the largest lake in the park. You will have the rest of the afternoon to explore in the park on your own and dine at one of the many venues within the park for dinner.

### **Day 5 Sunday, September 9 (B,D) Whitefish, MT**

Take a ride on Glacier Parks famous vintage red buses along the cedar and hemlock forests that lie within the Lake McDonald Valley. Traverse the famed Going-to-the-Sun Road to the high alpine region of the park and stand on top of the Continental Divide. Discover incredible mountain ranges, glaciers, waterfalls, wildlife and wildflowers along the way. Enjoy some free time in the park to grab some lunch or explore another trail before we head to the quaint town of Whitefish for dinner and then a relaxing evening at the lodge.

### **Day 6 Monday, September 10 (B,D) Holiday Inn Express, Butte, MT (1 night)**

After a scenic drive southward through the mountains, this evening we will all dine together and have some time to relax and get ready for the next leg of our journey.

### **Day 7 Tuesday, September 11 (B,D) Pahaska Tepee Lodge, Cody, WY (2 nights)**

We will make a stop in Cody, WY to learn all about the wild, wild west at the Buffalo Bill Museum before we head to our lodge in the woods for the evening. Nestled amongst the tall pines just east of Yellowstone Park at the foot of majestic Cody Peak lies the beautiful Pahaska Tepee Lodge, The ORIGINAL Buffalo Bill's Lodge in the Rockies. We will travel the Cody road to our lodge which is best known for its high mountains, pinnacle rock formations called hoodoos, the crystal clear North Fork of the Shoshone River and an abundant variety of wildlife. We will dine together at the lodge this evening before settling in for a relaxing evening.

### **Day 8 Wednesday, September 12 (B) Cody, WY**

Today we make our way around the northern grand loop of Yellowstone National Park. Experience the majesty of Mount Washburn, Madison River, Lamer Valley, the mammoth hot spring, beautiful geysers and so much more. There will be opportunity to dine in the park for lunch today before settling in for another relaxing evening in the mountains.

### **Day 9 Thursday, September 13 (B) Best Western Outlaw Inn, Rock Springs, WY (1 night)**

More great scenery as we tour the southern portion of the Yellowstone grand loop before heading to Rock Springs, WY. We will make various stops along the way including the "Grand Canyon" of Yellowstone, Old Faithful, the lower Yellowstone Falls and Hayden Valley. We will stop for lunch today at the Old Faithful Inn which is the largest log structure in the world and is on the national historic registry. On our way out of the park we will see the Grand Teton mountain range.

### **Day 10 Friday, September 14 (B,L) Ridgeline Resort, Estes Park, CO (2 nights)**

We arrive in the beautiful town of Estes Park Colorado today. After lunch and a tour of the historic Stanly Hotel, which inspired Stephen Kings best selling novel "The Shining", you will have time on your own to enjoy this beautiful Rocky mountain town.

### **Day 11 Saturday, September 15 (B,D) Estes Park, CO**

The day is all yours to explore the beautiful Rocky Mountain National Park. This evening we will all dine together and celebrate all we have experienced on this magnificent trip to the National Parks of the northern Rocky mountains!
