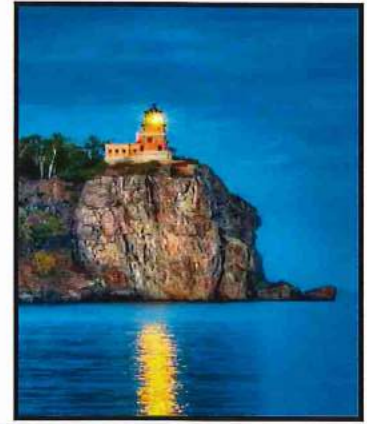




# Minnesota's Majestic North Shore

Next we are on to Gooseberry State Park to take in the mammoth waterfalls and beautiful scenery. After dinner we will settle in to our hotel in Beaver Bay for our 2 night stay.

### **Day 2: Monday, June 11th (B,L)**

Today we will stop at some of Minnesota's most impressive waterfalls and State Parks, we will ride the gondola at Lutsen for another breathtaking view of the beautiful Lake Superior shoreline and dine for lunch at the top of Moose Mountain. This afternoon we will visit Grand Portage National Monument Heritage Center before heading back to Beaver Bay for the evening.

### **Day 3: Tuesday, June 12th (B)**

Our journey continues as we head to Duluth for a beautiful, scenic train ride along the shores of Lake Superior and a visit to the spectacular Lake Superior Railroad Museum where you will find historical things such as President Lincoln's Funeral Car and artifacts from Minnesota's involvement in the Civil War.

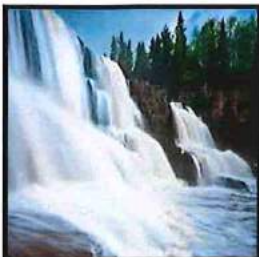
### **Day 4: Wednesday, June 13th (B,D)**

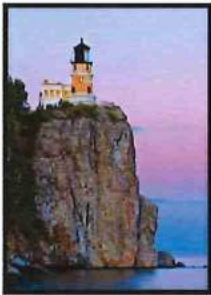
