Hampton Inn, Bloomington (2 nights)

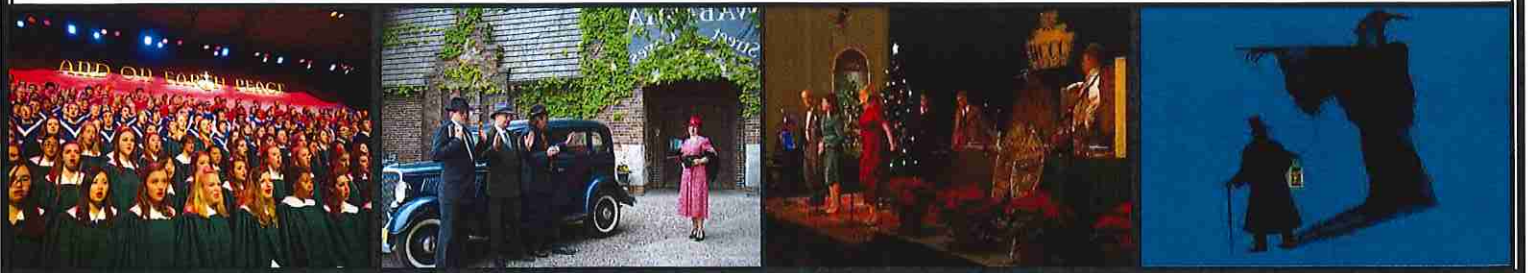

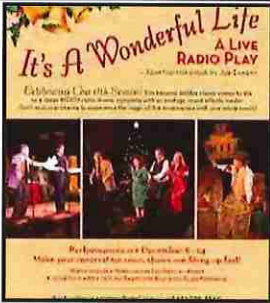
Day 2: Friday, December 6 (B, D)
