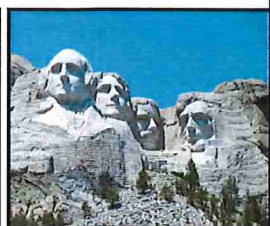
Day 8: Sunday, September 22 (B)
