Day 2, Wednesday, 10/23/19 (B,D)

At mid-day today, the history of the bible comes to life when we arrive at the world-class Creation Museum. On our walk through biblical history, we'll encounter a realistic Garden of Eden, animatronic Noah, flood dioramas, stunning video displays, and much more! This evening at the hotel we will enjoy an "Old Kentucky Home" buffet!

Day 3, Thursday, 10/24/19 (B,D)

Today we will explore the life-sized reconstruction of Noah's Ark. Built according the dimensions given in the Bible, Ark Encounter is a jaw-dropping structure! How did Noah fit and care for so many animals on board? What happened to Noah, the animals and the earth after the flood? Explore the answers to these questions and more as we visit the exhibits at the Ark. Following our Ark visit, we will tour the beautiful Cathedral Basilica of the Assumption, one of 85 minor basilicas in the United States. With its gothic architecture, 32 gargoyles reach out from the ornate upper colonnade, and 26 chimeras stand watchful guard against evil spirits. Our day will conclude with a relaxing dinner cruise on the mighty Ohio River.

Day 4, Friday, 10/25/19 (B,D)

Today we leave Covington and head to Springfield, Illinois. Upon our arrival we will visit the boy hood home of Abraham Lincoln. For dinner we will enjoy the Drury Inn's "Kick Back" complimentary food service featuring a variety of snacks, foods, and beverages.

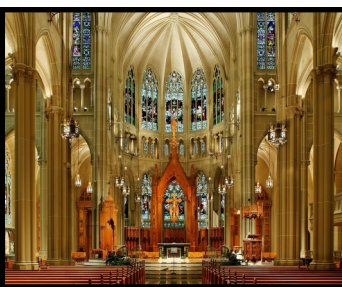
Drury Inn, Springfield, IL (2 nights)

Day 5, Saturday, 10/26/19 (B,D)

Our tour today begins with the Dana Thomas house, Frank Lloyd Wright's first "blank check" commission, built in 1902 and showcases 35 rooms in the 12,000 square foot of living space with 16 varying levels. Next on today's itinerary is a visit to Springfield's "Old State Capitol". Built in 1837, it is the site of candidacy announcements by Lincoln in 1858 and Barack Obama in 2007. Following lunch, we will find ourselves mesmerized within the walls of the Lincoln museum, considered to be the first major **Experience Museum** and combining priceless historical artifacts with innovative, contemporary storytelling technologies. Visitors are offered an engaging, emotional and educational experience through immersive, "you -are-there" exhibits. Our tour will end today with a visit to the Lincoln tomb. Tonight we will again enjoy the "Kick Back" food service at the Drury Inn.

Day 6, Sunday, 10/27/19 (B)

Following breakfast at the hotel, we will attend church and then make our way back home as we will reflect on the great time we had experiencing new adventures and making new friends!
