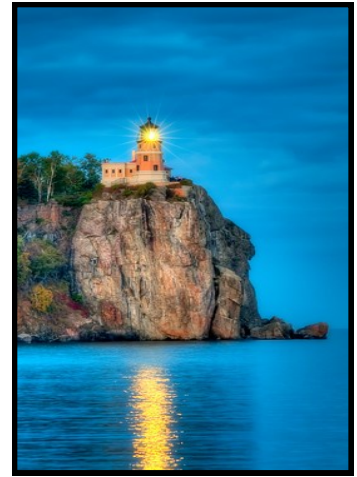




Lake Superior Circle Tour

Day 4: Thursday, September 12, 2019 (B,L)

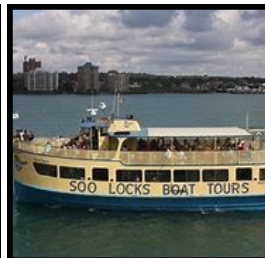
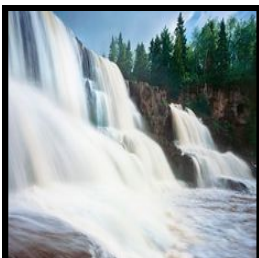
