Day 6, 7/24 (CB,D): Today we will travel to Nova Scotia, Canada. We will have dinner and later check into our Halifax, Nova Scotia area hotel for a two night stay.

Day 7, 7/25 (CB,D): Today we have a full day guided tour. Nova Scotia's Capital city of Halifax, Peggy's Cove, home of the most famous lighthouse in all of Canada and Old Town Lunenburg, where 70% of the original colonial buildings still stand today. Our tour also includes a visit to the Halifax Waterfront. This evening enjoy dinner before heading back to our hotel.

Day 8, 7/26 (CB,D): Free time in Charlottetown, the capital of Prince Edward Island. This evening we will have dinner and check into our hotel.

Day 9, 7/27 (CB,D): Guided tour of Prince Edward Island and a visit to the Green Gables Heritage Site. We will have dinner and head back towards New Brunswick, Canada to check into the hotel.

Day 10, 7/28 (CB,D): Today we see the famous Hopewell Rocks, which welcomes more than 180,000 visitors each year. Next we depart for the waterside town of Saint John, New Brunswick. Later dinner and check into our hotel.

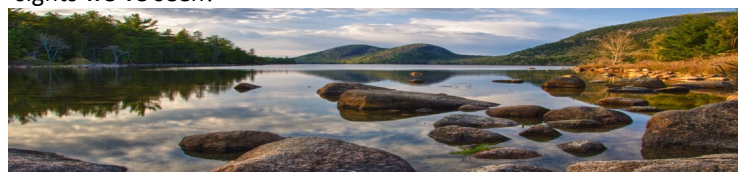
